Community Action Kentucky invites you to submit a proposal to present at our Annual Conference to be held June 17-18, 2020 in Louisville, Kentucky. The conference focuses on trends affecting Kentucky, program and community development, and policy.

Audience: Conference attendees are predominantly employees of Community Action Agencies in Kentucky. Attendees will range from outreach staff, management, to executive level staff. Specific tracks for Head Start, Transportation, and IT.

Session Topics: We are looking for session proposals to cover a variety of topics including, but not limited to:

- **Client Services:** Case Management; Social Determinates of Health; Workforce Development; Social Enterprise; Aging; Youth Programs; Affordable Housing; Marketing and Story Telling;
- **CSBG:** Organizational Standards; ROMA; Community Level Initiatives

- **Information Technology:** Cyber Security; Data Protection/Security; Data Tools (Excel); IT Audits; Disaster Recovery

 - Date/Time preference (we will try to accommodate date and time preferences if possible): Wednesday Morning, Wednesday Afternoon, Thursday Morning, or Thursday Afternoon
